3. Time and place:

Workshops will take place from 3rd to 14th July 2014 in The European Krzysztof Penderecki Center for Music in Luslawice 250, 32840 Zakliczyn

4. The objective of the Workshops is:

- exploration of the potential of a creative young human,
- Creation of a personal, individual identity,
- Development of talents under the care of qualified and competent masters,
- Formation of teamwork abilities,
- Teaching how to defeat stage-fright, ways to dominate it in public performances,
- Furthermore on Workshops is implemented an innovation and creative prophylaxis that's building good morals and support the struggle with addictions and pathologies

5. Conditions of participation in Workshops:

- 1) The participant of Workshops can be anyone regardless of age and sex. Underage persons are obligated to obtain a written agreement of his parents or keepers and bring it to the organizer the first day of Workshops.
- 2) **1500 PLN** payment for one person needs to be paid to this account:

in the title there needs to be written name and last name of the participant with postscript "Luslawice 2014"

ex: *John Smith Luslawice 2014.*

- 3) Number of places are limited. In case of a larger group of applications the priority have participants who paid first.
- 4) To make the name of the participant included on the list of accepted the price needs to be paid to the organization's account, and the confirmation of the payment needs to be send to email address warsztatypaniagaty@gmail.com
- 5) The price of workshops doesn't include transport.
- 6) Every participant needs to fill Application Form located on www.agatasteczowska.com
- 7) The sender of the Application Form becomes a participant in the moment when the full price has been paid and the organizer confirms his application.

- 8) The participant needs to accept terms and conditions of the Regulations of Workshops :
"I confirm my participation in 10th Agata Steczkowska's Artistic Master Workshops 2014. I certify that I read and accepted the terms and conditions of REGULATIONS of the Workshops. Zgodnie z In accordance with the law act from 29th august 1997 year about protection of the personal data, I allow to process my personal data by the Organizer."
 - 9) In case of a large number of applications and not being able to accept all the candidates on the list of participants of the Workshops the Organizer will make a stand-by list of the participants. The person who's on the standby list will be allowed to take place in the Workshops when there will be an opening of a free place on the list of the participants.
 - 10) Organizer guaranties in the price of the Workshops accommodation, meals, NNW PZU's insurance and the possibility of participation in every workshops.
 - 11) Organizer ensures 24 hours' care of qualified guardians for underage persons.
 - 12) Organizer has the right to make changes in the Program of the Workshops.
 - 13) Resignation of the participation in the Workshops is possible at the latest 60 days before the date of the beginning of the Workshops. Only then the organizer is obligated to return the full paid price. The resignation will be accepted only in the written form. The price will be returned to the account of the participant.
 - 14) In the unfortunate case of not being possible for the Workshops to be held for aleatory reasons, not independent of the Organizer, then the Organizer returns the full paid price to the participant.
 - 15) The participator or the person legally responsible is obligated to paid the Workshop's expenses and is fully financially responsible for the material damages caused by not respecting the Workshops Regulations and rules of a social cohabitation.
6. ORGANIZATION OF THE WORK ON WORKSHOPS
- 1) The participant of the Workshops is obligated to active and creative participation in the Workshop's exercises.
 - 2) Because of the character and the specificity of the lessons the frequency of the breaks and it's duration could change - the decision is made by the Master of the Workshop.
 - 3) Organizer guarantees a selection of experienced Masters to guide their workshops.
 - 4) Filming and photographing on the Workshops is allowed only by agreement of the Master. Organizer has the right to exclude persons from the lessons who disturb the classes and behave inappropriate.
7. FINAL DECISIONS
- 1) Every participant is obligated to respect the Regulations of The European Krzysztof Penderecki Center for Music in Luslawice.
 - 2) The price of damages made by the participant are paid by the participant or the person legally responsible for him.
 - 3) Personal data of the participants will be used accordingly with the law act from 29.08.1997 about protection of the personal data.

The administrator of the data is the Organizer. He will process the data only within the rules of the law of statutory activity, especially with the organization of the Workshops.
 - 4) Sending the Application Form is equivalent to accepting this Regulations.
 - 5) Organizer has the right to make changes the Regulations, but they can't mineralize the rights given to the participants.
